# InfoShare

## CONTENTS



**Intake:** A module that tracks all incoming incidents and allows the transfer of all intake information to the Investigations Module when further investigation is warranted.



**Investigation:** A module that gives quick access and updated information on all active and/ or closed cases of alleged crimes.



**Evidence:** This module tracks and records all evidence gathered for each case, and may be accessed by multiple users within a few seconds time.



**Screening:** Screening is defined as the decision-making process by which a prosecutor utilizes discretion to determine where a complaint should be referred to.



**Grand Jury:** A module that allows preparation of all cases prior to being presented to Grand Juries.



**Trial:** A module that allows preparation of all cases by attorneys to record all events concerning the trial. It also allows preparation of cases that are or will be appealed.



**Juvenile:** A module that enables the user to track a juvenile's progression through the court system, probation supervision, detention and other juvenile justice placements.



**Appellate:** A module used to track all case information and relevant events associated with the Appellate units of the enterprise criminal justice process.



**Motions:** The Motions Module tracks all motions filed for a particular case and defendant.



• **Forfeiture:** This module tracks defendant's assets seized and the storage and status of such cash, goods or property from the point of seizure, through trial, etc.



**Sex Offenders:** A module used to maintain, monitor and track sex offenders. It incorporates the use of GIS to track and plot offender locations relative to notification requirements.



• **Domestic Violence:** Tracks all Domestic Violence case information, including information about the victim, witness and defendant as well as any filed restraining orders.



**Task Force:** The primary goal of the task force is to work with local law enforcement agencies to investigate and prosecute those individuals involved in illegal drug trafficking.



**Fugitive:** A module that tracks all fugitive information including Arrest and Warrant information and provides a Fugitive Fact Sheet which shows the complete pedigree information of each fugitive including mugshots.



**Event Calendar:** This feature allows staff to schedule and monitor activities and to generate master calendars to reflect assigned cases any day of the week, month or year.



**Human Resources:** A module that allows maintenance of personnel records for easy access by staff members.



**Manuals:** A complete list of all directives issued by the Prosecutor, Chief or the Attorney General's office. An area for standard operating procedures to be displayed/updated.



• Legal Sites: Secured Internet access to specified legal sites for research and the latest information on judicial matters.

## FEATURES

- Security is enhanced through our Intranet system because users never have direct access to files at the operating system level. They receive their data from the Web Server, isolating them from the true data source through a custom interface enhancing the visual experience.
- InfoShare provides "**point and click**" access to any documents and/or files pertaining to new and old cases as well as for internal departmental messaging.
- InfoShare was designed using state of the art web based technology.
- InfoShare is **fully customizable** to meet the individual needs of every Prosecutor or Public Defender Office, Police Department and all other law enforcement agencies.
