#### **Public Health Software**

In 1979 QS was founded by public health professionals who had the vision of improving Patient Care, Clinic Management and Agency Management through integrated data systems. We recognized that the programmatic approach to information management was inefficient. It led to poorer patient care due to lack of medical information sharing between clinics with the same information being asked of the patient in each clinic, and long patient wait times because of the poorly managed clinic resources.

Immunization rates were low because records were not available in every clinic, leading to missed immunization opportunities. Clinic staffs were

spending time on report tabulation and manual thirdparty claims processing rather than providing medical services. Lacking a unified data system,



agency managers could not view resource utilization across clinics and plan accordingly.

## **Our Approach**

We developed our first product, the Health Management Information System (HMIS), to provide a fully integrated public health solution. The core of our information structure is a single, common patient registration record, capturing identification and demographic information on each patient; registration is immediately made available to all health department programs.

An integral tool in managing patient flow and increasing clinic efficiency is a common appointment scheduling system which allows clinics to schedule resources in their own and other clinics to meet patient needs without making the patient talk to many separate individuals to schedule services. A common appointment system improves clinic utilization through appointment

reminder/recall letters; it gives clinic managers the necessary statistical information to schedule staff and clinic times; it gives agency managers an evaluation tool for clinics and the information necessary to allocate resources to clinics. A common encounter recording system allows the clinician to be aware of other services the patient is receiving, simplifies billing functions, and provides a wealth of management information on the services being delivered by the agency.

#### COTS


In the early days, customized software solutions were the norm. Such an approach leads to development and documentation resources being used to invent the wheel over and over. Our major thrust at QS was to unify software development and to create a single, flexible system to serve the needs of public agencies. That approach is now called COTS (Commercial Off-The-Shelf Software). The resulting product was what we call the Patient Care Management System (PCMS).

## Insight

Insight was started in 1996 as a graphical alternative to PCMS. Although Insight shares a database similar in content to PCMS, it was a newly designed and constructed software product, built as a native 32-bit Microsoft Windows client/Microsoft SQL server application. Insight offers many features beyond what could be accomplished in a character-based product. Because *Insight* is an integrated package, its architecture, screen design, database, and deployment options are the same for all functional areas. With hundreds of user-defined data validation code tables. Insight offers a flexible COTS approach with a health department personal touch. Patient Registration is the only required module. All other modules may be purchased as needed. Insight remains in the forefront of technology advances. New modules are added with each release. We are committed to CDC PHIN compatibility. To this end, we are developing PHINcompliant data collection and messaging. Today, Insight is deployed statewide in New Mexico and in county locations across the continental US and Alaska.
