The need for rapid information regarding the staff and visitors has never been greater. Organizations are taking a closer look at how they would - and could - react to an emergency and ensure the safety of their personnel.

personnel location information. Many organizations already employ some type of entry authorization procedure or system. PVS can utilize these established solutions for data validation and extends their functionality to track elements after the point of entry or after an event requiring evacuation of personnel.

PVS also tracks both company owned and personal assets. Company owned assets are monitored for financial and security reasons, controlling who has the authority to remove an asset from the premises. Individual assets are tracked for safety and security reasons, so that items brought into the PVS managed area by an employee or visitor are removed upon departure.

During an emergency event, personnel report to a designated rally point. Once at the rally point, handheld scanners are used to account for all personnel. Management can ensure that everyone exited safely by monitoring the online event reports on their handheld devices. Should anyone not be accounted for, rescue efforts can be focused on the last location tracked for that individual. The emergency response team can then verify the missing person's identity and last known location.

Management and emergency response teams in organizations across the United States are scrutinizing their plans and renewing their commitment to personnel security. In order to maintain a secure environment, organizations must be concerned with various temporary personnel visiting their facility including vendors, contractors, delivery persons and visitors. The **Personnel Visibility System (PVS)** fulfills today's high security standards for permanent and temporary personnel as well as visitors. The ability to track assets as they enter or leave a facility provides additional compound security.

Application Overview

The main purpose of PVS is to maintain an active accounting of personnel present within a controlled area and allow on-demand reporting during normal operations and emergency events. It tracks and controls who enters/exits by time and location. The system provides visitor and
